Commissioner Tippetts called the meeting to order at 3:00 PM on January 28, 2026. He welcomed everyone in attendance. The purpose of this public hearing is to supply citizens with pertinent information and receive input on the Community Development Block Grant program and to allow for discussion of possible applications for the 2026 funding cycle.

- I. The region will receive approximately \$785,848.
- II. There are a variety of projects that are eligible under the CDBG Program. Some of the projects are:
 - a. Acquisition of Real Property
 - b. Acquisition and construction of public works.
 - c. Code enforcement
 - d. Demolition
 - e. Removal of architectural barriers

- f. Provision of public services
 - g. Required matching funds
 - h. Relocation payments
 - i. Planning activities
 - j. Administration of federal programs
 - k. Housing assistance
 - l. Economic Development
 - m. Housing Activities
- III. Commissioner Tippetts asked if there were any questions about the variety of projects that are eligible for the program. There were no questions or comments.
- IV. The Community Development funding must be used for activities that will meet the national objective of benefit to low/moderate income individuals. In addition to low/moderate there are two other ways to meet the national objective. They are the prevention or elimination of slum or blight and urgent health and welfare.
- V. If any proposed Community Development project results in displacement of low/moderate income individuals, then provisions will be made to assist in funding new housing.
- VI. Entity and CDBG Project allocations throughout the year's handout. Kevin Yack stated that we have a list available of projects that have been funded in our region; Daggett, Duchesne, and Uintah Counties from the beginning of the Community Development Block Grant program until current, which all meet the national objectives.
- VII. Commissioner Tippetts asked if anyone has any questions or comments or any suggestions.

Kevin Yack stated that we will continue to try and meet the demands that we see as an agency and look for ways to apply for funding to assist individuals with housing and community services that are needed in our region.
