- Sandra Haak gave the board an update about the orchard. New trees were planted. Deer were rubbing their antlers on the trees to remove the velvet. Fences were placed to protect the trees. Totes that hold 275 gallons of water were installed as back-up irrigation.

Presentation - Austin Green

- Professor Austin Green presented research findings on coyote behavioral plasticity in Dimple Dell, noting they become more nocturnal near humans to avoid pressure. He also discussed research showing that fawning mule deer are more adapted to urban cover than adult mule deer, potentially using humans as a shield from natural predators. Dimple Dell was identified as one of the most biodiverse urban green spaces in Salt Lake County.
- Questions raised by the board:
 - Differences of Dimple Dell Park in comparison with other urban areas.
 - Are the deer recognizable?
 - How is the health of the eco-system?

Board Meeting Frequency Discussion

- The board decided to change their meeting frequency from quarterly to every other month starting in February.

Permit Requirement Discussion

- Presented by Patrick Leary:
- It was confirmed that event applicants must submit their request to the county 60 days in advance, which gives the board time to weigh in on non-routine permits (e.g., commercial filming). Routine events or walks do not typically pose an issue.
