Distribution October 22, 2025, Minutes

The minutes for the Council Workshop Meeting held on October 22, 2025, were distributed prior to the meeting.

Division Updates

Patrick Craig reviewed the Division Update sheet that was provided as part of the meeting package. Update on Securely Covered Loads: July to December 2025 train our customers on the new law. From January to June 2026 each customer would receive one warning. July 1, 2026, all loads not complying will pay double the disposal fees. DEQ and Health Department fees are not charged twice. Momentum Glass: Salt Lake City and Momentum Glass Recycling approached the Landfill to request an area to store partial processed glass. A major customer of Momentum has suspended operations, and this has caused a storage space issue. Without additional storage space, Momentum would have to limit the current collection of glass from the bins around the county. The landfill has some space available to allow the storage of this material. We have spoken to DEQ and the Health Department for approvals. Ryan Lambert will prepare an agreement. **Chris Bell** adds Momentum Glass is the only glass recycler in the state of Utah. They are an important resource for sustainability, and the eco system for the region. Momentum obtains glass from Montana, Idaho, and Wyoming. We want to support them to keep their volume flowing.

Financial Report

Patrick Craig reviewed the January to September 2025 Financial Report of Expense and Revenues, MSW Report, Compost Report, and Top MSW Customers which were provided as part of the meeting package. Revenue exceeds the anticipated budget.

Homeless Camp Cleanup Fee Waiver Request

Patrick Craig presented the letter for the 2026 Homeless Camp Cleanup Fee Waiver Request. **Ron Lund** expressed the importance of mitigating the homeless cleanups.

Other Business

The Council members thanked Mayor Smolka for his service on the council. **Joe Smolka** adds the Salt Lake County Council of Governments will be nominating and approving a replacement soon. **Chris Bell** will be the SWMC Chairman for 2026.






LANDFILL REVENUE RECEIVED VS EXPEC...
