Central Jordan River Reconnect Master Plan Implementation Coordination & Discussion : Brian Trusty, Principal of Park Operations & Maintenance with PROS Consulting, and Brandon Biederman, Associate Principal and Project Manager with the consulting team from PORT, will lead a discussion about approaches to coordinated park development, management and maintenance related to the “Central Jordan River Reconnect” Regional Park Master Plan for Salt Lake County (<https://www.centraljordanreconnect.com>). This discussion may have broader application to other areas and regional parks and natural lands across the Jordan River Parkway, and the possible roles of the Jordan River Commission or other entities.
- b. Great Salt Lake Sentinel Landscape : Marisa Weinberg, Program Manager and Coordinator for the Great Salt Lake Sentinel Landscape, will share information about this recently designated entity and partnership, which includes over 2.7 million acres in northern Utah related to four military installations—Hill Air Force Base, Camp Williams, Tooele Army Depot, and Little Mountain Test Facility—with a focus on environmental conservation and community resilience in the communities around these facilities (<https://sentinellandscapes.org/landscapes/great-salt-lake>).
