RESOLUTION 26-06

A RESOLUTION AMENDING THE CLARKSTON TOWN MASTER FEE SCHEDULE TO DECREASE THE RENTAL FEE OF THE COMMUNITY CENTER, AMPHITHEATER, AND PAVILIONS

WHEREAS, the Clarkston Town Council felt the rental fees of the Community Centers, the Amphitheater, and the Pavilions were excessive for citizens, they have determined the following charges going forward:

- Community Centers: \$25 for a 3-5 hour rental with a \$100/deposit
- Amphitheater: no rental fee with a \$100/deposit
- Pavilion: no rental fee

NOW THEREFORE BE IT RESOLVED that the Clarkston Town Master Fee Schedule shall be amended to decrease the Community Center, Amphitheater, and Pavilion Rental fees.
