#### 4. DISCUSSION AND POSSIBLE ACTION ITEMS

##### 4.1. **Online Open Meetings Act Training**

All in attendance participated in the open meetings act training and successfully completed the training.

##### 4.2. **Legislation**, Talia Butler, Division Director; Jami Johanson, Associate Division Director

Talia provided a summary of the current bills related to animals in the 2026 Utah State Legislative session. Talia explained that we are closely following and in support of HB 87 Animal Crime Victim Amendments, related to seeking swift disposition for animals being held on court holds, and SB 102 Animal Control First Responder Amendments, which would classify animal control officers as first responders alongside other law enforcement officers.

Animal Services asked members for their support in helping get these bills passed and Carrie will distribute a support letter if members and their city officials would like to sign to show support.

Other bills Animal Services is monitoring includes SB70 related to sheltering during emergencies, SB201 related to shelter euthanasia amendments that clarifies requirements before shelter animals are euthanized, and a bill that addresses penalties related to distribution of animal cruelty images and media.

Dustin asked if there are any current bills related to puppy mills and backyard breeders. Talia explained that so far there is nothing related to that on legislature yet.

**4.3. Division Updates,** Talia Butler, Division Director; Jami Johanson, Associate Division Director

Jami Johanson highlighted a court hold case involving a dog named Biscuit that ended with a successful adoption. Jami also went over upcoming events including the fundraising event Treadbowl and Spring into Love Easter adoption event. Jami also provided a summary of this year's capital projects.

Jami and Dustin also highlighted a recent hoarding case and animal control and other agencies efforts to take possession of the various animals and provide assistance to the home owner.

# LEGISLATIVE INITIATIVES



## H.B. 87 Animal Crime Victim Amendments

Require courts to determine disposition of animals held in cruelty cases at the first scheduled hearing. Does not require owner attendance. Addresses cost of care.

### *Benefits*

- Clarifying provisions related to the release & forfeiture of animals reducing unnecessary hold times
- Prioritizes animal welfare in abusive and/or exploitive cases.

## S.B. 102 Animal Control First Responder Amendments

Currently the law only includes animal control officers that are part of a police or sheriff agency. Requesting change to include all municipal animal control employees that meet the first responder requirements.

### *Benefits*

- Strengthens workforce readiness by extending access to first responder mental health and substance use resources
- Improves coordination within emergency and public safety systems, benefiting dispatchers, responders, and the public

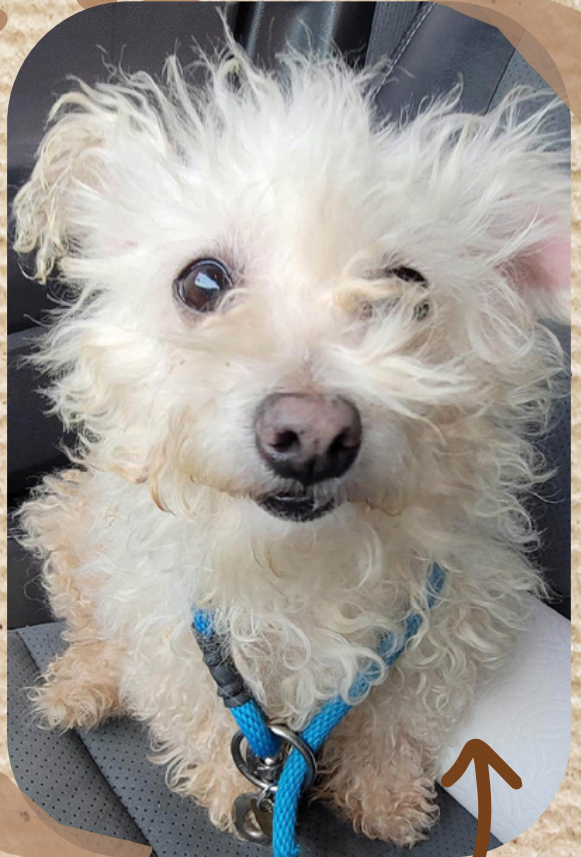
