ORDINANCE NO. 26-02

AN ORDINANCE AMENDING RIVERTON CITY CODE SECTION TITLE 2.95.030
[PLANNING COMMISSION OFFICERS]

WHEREAS, Utah Code section 10-20-301 requires the Riverton City Council to establish by ordinance the Riverton City Planning Commission ("Planning Commission"); and

WHEREAS, said ordinance is required to include procedures to select a chair and vice chair of the Planning Commission; and

WHEREAS, Riverton City Code section 2.95.030 addresses the selection of a chair and vice chair; and

WHEREAS, Mayor Buroker, after conferring with a representative of the Planning Commission, has recommended that the officials appointed to serve as chair and vice chair of the Planning Commission not be strictly confined to terms in office that last for a single year; and

WHEREAS, the Riverton City Council finds and determines that in certain instances, the Planning Commission may be better served if its chair and vice chair serve in these roles for periods of time which exceed one year; and

WHEREAS, the Riverton City Council finds and determines that an amendment to Riverton City Code section 2.95.030 as presented by staff will provide greater flexibility to the Planning Commission in selecting commissioners to serve as chair and vice chair;

NOW, THEREFORE, BE IT ORDAINED by the City Council of Riverton City as follows:

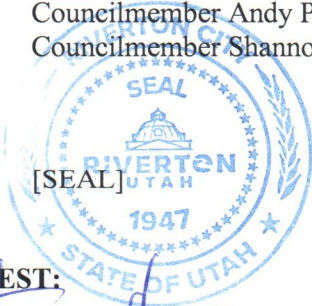
Section 1. Amendment. The Riverton City Code Section 2.95.030 is hereby to read as follows in the attached Exhibit A.

Section 2. Adoption. This ordinance shall take effect on publication in compliance with Utah Law.

§ 2.95.030 Officers.

The planning commission shall elect annually, during a regularly scheduled meeting, a chair and a vice-chair of the commission, who may be allowed to succeed themselves. They will be elected from among the members of the planning commission by a majority of the total membership.

The duties and responsibilities of the chair shall be to direct planning commission meetings and to keep order within those meetings. In the event that the chair is not present at the planning commission meeting it shall be the duty of the vice-chair to be responsible for the chair's duties. The chair shall be a full voting member of the planning commission.

§ 2.95.030 Officers.
