ADMINISTRATIVE MATTERS

Call to Order:

Resolution Ratifying the Previously Approved Motion Authorizing the District to Reimburse Spanish Fork City up to \$27,500,000:

Ms. Clymer provided an update on the reimbursement to Spanish Fork City. Discussion ensued. Ms. Clymer indicated she will obtain the necessary signatures and certification for the requisition and distribute to the appropriate parties. Following discussion, Trustee Wolford made a motion to adopt the Resolution Ratifying the Previously Approved Motion Authorizing the District to Reimburse Spanish Fork City up to \$27,500,000. Trustee Tanner seconded the motion. The motion passed unanimously.

The Board discussed the District bank account. Trustee Wolford will send the bank account number to CLA in order for CLA to complete the Bill.com setup to process payments and provide payment instructions to UIPA in order to receive the tax differential payments.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, CliftonLarsonAllen LLP (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
