On January 27, 2026, Enbridge Gas Utah (EGU) filed with the Public Service Commission (PSC) a Notice of Intent to File IRP and Request for Scheduling Order and Notice of Technical Conferences ("Notice"). The Notice states EGU intends to file its integrated resource plan for the plan year of June 1, 2026, through May 31, 2027 ("2026 IRP") in early June 2026.
