Annual Conflict of Interest Disclosure Form

The following disclosures are required to be made annually by all officers of Firefly Public Infrastructure District Nos. 1-10 pursuant to Utah Code Annotated 17-16a-6, Utah Code Annotated 17-16a-7, and Utah Code Annotated 17-16a-8. If additional space is needed, please use a separate sheet of paper. Per statute, the information provided shall be kept on file with the Board of Trustees and may be subject to disclosure to the public.

I, Bryan Flamm, am the duly elected/appointed Clerk/Secretary of Firefly Public Infrastructure District Nos. 1-10.

Ownership of a substantial interest is defined in U.C.A. 17-16a-3(8) as an interest of 10% or more of the shares of a corporation, or a 10% or more ownership interest in other entities, legally or equitably held or owned by the officer, the officer's spouse, or the officer's children.

*Note: There is no case law or statutory guidance as to what constitutes a business entity "subject to regulation of the County." A business which is simply issued a business license by the County may or may not be deemed by a court, administrative agency, an auditor, or member of the public to be an entity regulated by the County. Businesses regulated by interlocal agencies of which the County is a member may or may not be deemed to be a business regulated by the County (i.e., a restaurant subject to regulations imposed by an interlocal agency).

A business entity which requires a conditional use permit to operate may more likely be deemed to be a business entity regulated by the public infrastructure districts than a business that simply receives a business license from the County.


