1. Site Plan – Home Depot - Located generally at 655 E Park Avenue in the PD34 zone

Grace Bjarnson introduced the Home Depot site plan, noting the complexity of the situation involving plat amendments and rezoning for the property south of the Costco in Orem. The site, in the PD34 zone, will include a garden center, and lot line adjustments. A tall fence is planned to mitigate sound for neighbors. Grace Bjarnson requested a motion.

DRC Action: Rick Sabey moved to recommend approval of the Home Depot site plan, located at approximately 655 East Park Avenue in the PD34 zone, conditioned on the approval of the associated plat amendment. Derek Spencer seconded the motion.

2. Temporary Site Plan – Alpine Aqueduct - Located generally at 1200 E 800 North in the R12 zone.

Grace Bjarnson presented a temporary site plan for the Alpine Aqueduct, where the Central Utah Water Conservancy District is conducting a project that blocks resident parking. The plan involves creating a temporary parking area at approximately 1230 North in the R12 zone, with a 24/7 guard and shuttle service for affected residents, and the project is scheduled to start in March and run until the end of August. Grace Bjarnson requested a motion.

DRC Action: Darren Pead moved to recommend approval of the temporary site plan, with the condition that the existing water valves to the west of the parking lot be protected. Rick Sabey seconded the motion.
