3. A Performance Audit of Utah State University's Governance, Leadership, and Culture

Jesse Martinson, Audit Manager, and Nick Varney, Audit Supervisor, Office of Legislative Auditor General, discussed the performance audit.

Sen. Kwan asked for more information about the succession planning. Jesse Martinson responded.

Sen. Riebe asked questions about the requirements of Board of Trustees members and offering more incentives for university presidents to stay. Jesse Martinson responded.

Sen. Millner asked if other institutions practices have been evaluated. She also asked if the recommendations would mean increases in staff and administration positions. Jesse Martinson responded.

Brad Mortensen, President, Utah State University (USU) recognized members of the Board of Trustees and the USU student body president.

Pres. Mortensen responded to the audit findings and discussed changes that are being implemented as a result of the audit.

Geoff Landward, Commissioner, Utah System of Higher Education, responded to the audit findings. He also discussed future succession plans.

Sen. Wilson thanked the commissioner's office and the audit staff. He mentioned the bill in his name, S.B. 240, that is associated with this issue.

Sen. Riebe expressed concern about the legislation being applicable for every institution. She also expressed concern for requiring more of the Board of Trustees. Geoff Landward responded.

Sen. Kwan agreed that more training should be involved. She discussed the findings to increase funding with respect to enrollment and teaching loads. Pres. Mortensen responded.

Rep. Walter stated that clarifying the role of the Board of Trustees is a helpful recommendation.

Chair Koford thanked Pres. Mortensen for accepting the position of president during such a challenging time.
