## **RESOLUTION NO. 26-03**

### **A RESOLUTION OF THE CITY OF TAYLORSVILLE APPOINTING B. MURPHY AS AN ALTERNATE TO THE PLANNING COMMISSION.**

**WHEREAS**, the Taylorsville City Council (the “Council”) met in regular session on February 18, 2026 to consider, among other things, appointing B. Murphy as alternate to the Planning Commission; and

**WHEREAS**, TAYLORSVILLE MUNICIPAL CODE §13.03.030(A)(2)(a) directs that members of the City’s Planning Commission are to be appointed by the City Council, including one (1) alternate member; and

**WHEREAS**, on June 4, 2026 David Young was appointed to serve as the alternate to the Planning Commission, with his term to expire on June 30, 2028; and

**WHEREAS**, on January 7, 2026 David Young was appointed to serve on the Planning Commission as a representative of District No. 1, vacating his position as an alternate; and

**WHEREAS**, the City wishes to appoint B. Murphy to serve the remainder of Mr. Young’s term as an alternate; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the City’s citizens to appoint B. Murphy as an alternate on the Planning Commission, with the term to expire on June 30, 2028.

**NOW, THEREFORE, BE IT RESOLVED** by the Taylorsville City Council that B. Murphy is hereby appointed as alternate to the Planning Commission.

This Resolution, assigned Resolution No. 26-03, shall take effect immediately upon passage and acceptance as provided herein.
