137 Section . is enacted to read:

138 Carbon dioxide system licensing and certification required for certain
139 activities – Licensing and certification procedures.

140 (1){A}On or after January 1, 2027, a person may not engage in the business of servicing a carbon dioxide system unless

141 the person is currently licensed by the state fire marshal.

142 (2)(a){E}On or after January 1, 2027, except as provided by Subsection (2)(b), an individual may not service a carbon

143 dioxide system unless the individual is currently certified by the state fire marshal.

144 (b)Subsection (2)(a) does not apply to:

145 (i)a fire officer; or
