1. Public hearing to discuss submitting an application to the Permanent Community Impact Board for funding on an Aquifer Storage and Recovery Study.	<p>The public hearing was opened. Garrick Willden, Water Manager, presented information regarding the proposed Aquifer Storage and Recovery (ASR) Study.</p> <p>Mr. Willden explained that the study would evaluate the feasibility of recharging the Town's aquifer to increase water storage capacity and improve water quality. One of the Town's wells has nitrate levels of approximately 12–13 ppm, and the Town currently uses a blending program with spring water to maintain compliance. During winter months, excess spring water could potentially be injected into the well to improve water quality and storage capacity.</p> <p>He stated that the Town has a treatment plant to treat the water due to high nitrates when the springs run dry, which results in increased operational costs and drought rates. The proposed study would involve working with a hydrogeologist to determine feasibility, followed by permitting, design, and construction phases if viable. Much of the infrastructure is already in place. The estimated cost of the study is \$30,000, with a request to CIB for \$15,000 and a \$15,000 Town match. The application has been submitted and accepted.</p> <p>No public comments were made. The public hearing was closed.</p>

Cade Penney- updates from R6</p>	<p>A motion was made to authorize the Mayor's signature on the annexation agreement for Vearl Christiansen and to approve the ordinance annexing certain real property into Mayfield Town and extending the Town boundaries.</p> <p>This matter is tabled.</p> <p>Ordinance 2026-1, adopting regulations for Internal Accessory Dwelling Units (IADUs), was read into the record by Recorder Bennett. A motion was made to approve Ordinance 2026-1.</p> <p>Cade Penney provided updates and reminded the Council that the UORG Grant application is due March 17. A cost estimate for equipment will be required. He also announced the Regional Growth Summit scheduled for May 6.</p> <p>Captain Steven Saltair with DVFD introduced Jed Hansen as the 2026 Chief. Chief Hansen reported that Zack Jensen will serve as Assistant Chief. Two GVFD members reside in Mayfield: Kevin Seely and Clayton Meyer. Chief Hansen distributed a report showing 81 call-outs in the past year. The majority involved carbon monoxide and fire alarm calls. Most wildland fire responses are reimbursable. Mayfield accounted for 4.6% of total call-outs while contributing approximately 9% of the department's budget. Council discussion included the potential benefit of acquiring a building or equipment for the department. Chief Hansen explained that costs for equipment are substantial. A Type 1 fire truck costs approximately \$100,000. Personal protective equipment for one firefighter is approximately \$12,000. Self-contained breathing apparatus (SCBA) units cost approximately \$10,000 each, with a minimum of four required. NFPA regulations limit equipment life to ten years.
