- B. Annual Review of School Fees Policy – Leon Wilcox, Business Administrator

USBE Rule R277-407-15(5) was updated December 2025 to require the District's policy on school fees and fundraising be reviewed annually. Mr. Wilcox reviewed school fees, fundraisers, fee waivers and donation policy. The new deadline to adopt the fee schedule for the next school year is now June 1st. The District must establish a path to graduation that does not require a fee or waiver starting in the 2026-2027 school year. Presentation and documents available on [Diligent Community](#).

C. 2026-2027 Fee Schedule (First Reading) – Leon Wilcox, Business Administrator

State Executive Appropriations Committee recommended to return the 17.5M distributed in FY26 from the School Fees offset appropriation to increase the Catalyst Center funding. It's likely the FY27 and FY28 School Fees offset appropriation will no longer be available. The District will allow schools to keep what has already been distributed to them.

As a result of not collecting registration fees, schools are now accruing expenses for credit card processing fees up to \$40,000 per school, custodial overtime for Saturday events and practices are up to \$60,000 per year for all schools, assistant coaches up to \$40,000 per school and cost for HUDL of approximately \$25,000 per school.

Proposed fee increases for FY27 for middle school, high school and CTEC were reviewed. No increase for elementary schools.

Proposed school fees legislation include HB121 may charge class fee for science classes and HB142 – no fee waiver for second school trip. 8. New Business

- A. State of the Arts Reports – Dr. Amber Roderick-Landward, Director of ISD

The CSD State of the Arts team reported that the arts engagement of students in CSD is strong across all levels and content areas because of excellent teachers, established programs, continuous innovation and strong school and district support. Teams meet multiple times a year to explore the successes and needs of their teachers, plan PLC time, and structure professional development opportunities. CSD has added new classes, programs, class levels, and general

music classes. CSD Middle schools have added music technology and a history of rock as a class option.

The Beverly Taylor Sorenson (BTS) has helped provide an Arts/Special Education partnership in some schools and allotted additional hours for collaboration and co-teaching. The District provides many events and programs and celebrates success through competitions and performances.

The Arts are also a perfect avenue for students to grow in all the six core competencies of the Portrait of a Canyons Scholar and a way to connect to the strategic plan.

Future goals and initiatives include, amplifying and acknowledging instructional success, capturing and analyzing the increase in integrated instruction in elementary schools, deepening and increasing support and resources, exploring methods for improvement in the quality of vertical alignment and work with teacher leadership teams to refine instructional guides and professional learning. Superintendent Robins highlighted indicators used to measure information for the focus areas of High-Quality Learning, Human Centered Supports, Operating Systems, and Access and Opportunity.
