Summary: Wasatch County posted the availability of Planning Commission seats and interviewed applicants to fill those seats in January 2026. Five applications were received with five vacancies on the Commission.

Two seats on the Planning Commission expired in December 2025. Additionally, one regular member resigned in December 2025 and an Associate Member resigned in June 2025. It is recommended that Kimberly Cook and Mark Hendricks be reappointed as regular members with Michael Murphy being appointed as a Regular member, having been an Associate Member. Harold Wilson and Mark Trenchard are recommended to fill the vacancies in the Associate Member roles. Consideration of appointing Kimberly Cook, Mark Hendricks, and Michael Murphy as Regular Members of the Planning Commission and Harold Wilson and Mark Trenchard as Associate Members of the Planning Commission

1. Heber Valley Tourism Grant Recipients Presentation – Dallin Koecher

Summary: Annually HVTED awards \$50,000 in grants to help promote events in Wasatch County. The grant is a matching, post performance grant. We reimburse up to 50% of costs associated with marketing events to attract visitors to Wasatch County. The Tourism Tax Advisory Board reviews applications, scores, and allocates the grant money. Staff then follows up with the event promoter for reports, proof of expenses, and presents completed reports to the TTAB board for final approval. Once approved, staff issues payment. We are presenting to the Council the awards as part of our process and to keep the council informed of how TRT is being used.

2. Victims Advocate Program Update – Kristin Guthrie
