Building permit fees shall be paid prior to any work being started. The current building valuation data from the International Code Council and a regional multiplier of .75 will be used in determining cost per square foot based on occupancy and building type. In addition to the fees set forth, a 1% state surcharge is assessed.

Ambulance

Ambulance Rates shall be those specified by rules 426-1-8(3), (5), (6), (7) and (8) published by Utah State Department of Health, Bureau of Emergency Medical Services as the same may be amended from time-to-time by Utah State Department of Health, Bureau of Emergency Medical Services, or in any other subsequent provisions which may be adopted by Utah State Department of Health, Bureau of Emergency Medical Services.

The Fire Chief may approve the use of an ambulance to standby at an even or activity. The fee for such standby service shall be the call rate specified in the previous paragraph, plus \$4.50 per quarter hour or portion thereof for all time, which the ambulance is at the event in excess of 30 minutes.

A co-signer can be accepted in-lieu of a deposit if approved first by the City. A co-signer must own their home, have a current utility account with Payson City and must have good payment history. Co-signers must come into the office to sign the application in front of staff, and provide a copy of their driver's license. In the event Customer defaults on payment, Co-signer agrees to give Payson City the right to attach any delinquent amount to Co-signer's personal utility account. Co-signer's utility service will subject to disconnection if acceptable arrangements are not made with Payson City to pay off above referenced delinquent amounts.

Homeowner deposits will be applied to the utility account after six (6) consecutive months of full payments, . made on or before the due date. Renter's and mobile home deposits, will be held and applied to the final bill.

A deposit will be required on all new building accounts to be paid with the building permit.

A customer who believes that their bill is in error, or wishes to discuss or dispute the bill for any reason, may request and receive a hearing with a Payson City official prior to interruption of service.

Return payments. A \$20 fee will be assessed to each return payment. All forms of return payments are subject to the \$20 fee. The \$20 fee may be waived on return payments due to fraudulent bank activity, upon submission of proof of fraud.

Contested billings. Time frame: it is the responsibility of the utility customer to review their own utility bills. All utility bills issued to utility customers shall be deemed to be correct if they are not disputed by the utility customer within one (1) year from the issuance.

Process. Within one (1) year, utility customers may contest billings by requesting a review of the charges by the utility billing clerk. If unresolved, customers may request a review of the charges by the utility billing department and/or the finance director. The utility billing department and/or the city finance director shall gather all applicable information and documentation of the disputed charges from the utility billing clerk and the customer and determine the validity of the billing. Once a determination has been made, the charges will either be adjusted or payable by the due date of the bill or within five (5) days of the determination. If the due date has passed,

Power Cost Adjustment Rider (PCA)

Applicability:

The PCA will apply to all Payson Power Rate Schedules except non-metered and special contract rates.

Calculation:

The PCA will be calculated using the most recent six month's actual power cost and applied to each customer's following monthly billed energy (kWh) or a two-month lag from when the cost occurred to be billed.

The PCA adjustment shall be calculated according to the following formula:

$$PCA = P/S - B$$

P = Wholesale power supply cost, costs associated with the internal generation (natural gas, diesel, oil and chemicals), and 50% of future off-system debt related to SUVPS transmission cost (transmission upgrades are to increase capacity and improve system reliability).

Utility cost of power during previous six-month period calculated using the most recent six month's actual power cost plus periodic true up of accumulated positive or negative balance of recovered cost of power resulting from the application of the PCA. If an unusual occurrence happens resulting in abnormally high cost the Management/Governing body will determine whether the cost should be recovered over a longer period.

S = Number of kilowatt-hours sold

Sales are estimated by multiplying kilowatt-hours purchased by (1-Losses), during the same period as factor "P". The system's annual average loss factor is 6%.

B = This amount reflects the average cost of power per kilowatt-hour sold and recovered through base retail rates (\$0.0689)

If the PCA calculation results in a credit, the credit will only be provided if operating cash is above the minimum requirements of \$4.0M. Operating cash is defined as funds not restricted for a specific purpose.

Impact fees for irrigated acreage should only be charged to developments that do not have access to the pressurized irrigation system. The proposed drinking water system impact fee for one irrigated acre is **\$10,912**. For purposes of this study, a typical single-family residence in Payson will be defined as a 15,000 square foot lot with an irrigated area of 0.15 acres, plus 0.03 irr-ac for parks and open space. Accordingly, the proposed drinking water system impact fee for one typical residential connection with 0.18 acres irrigated with the drinking water system is **\$3,968** (\$2,004 + (0.18 x \$10,912)). Alternatively, the City may calculate an impact fee for a non-residential connection based on projected peak day water use according to the following formula:

$$\text{ERCs} = (\text{Peak Day Water use, gpd}) / (500 \text{ gpd per ERC})$$

$$\text{Impact fee} = \text{ERC} * \$2,004$$

For example, if a customer will use 20 gpm of water on the peak day, the impact fee may be

$$\text{Peak day water use} = 20 \text{ gal/min} * 1,440 \text{ min/day} = 28,800 \text{ gpd}$$

$$\text{ERCs} = (28,800 \text{ gpd}) / (500 \text{ gpd per ERC}) = 57.6 \text{ ERCs}$$

$$\text{Impact fee} = 57.6 \text{ ERCs} * \$2,004/\text{ERC} = \mathbf{\$115,430}$$

Given that wastewater collection is not metered, and given that wastewater loading is created by water passing through the drinking water meter, the wastewater impact fee is based on drinking water use. The impact fee above has been calculated based on 1 ERU, which would correspond to a standard 1" drinking water meter. Larger drinking water meters are assumed to serve more than 1 ERU and will have a higher corresponding drinking and wastewater impact fees. The table above indicates the impact fee rate schedule based on water meter size. The ERU factor is calculated based on American Water Works Association (AWWA) rated capacity for each meter size. This represents an equitable distribution of potential to use the city's sewer system. ERU capacity for users requiring larger meters will be assessed individually by the City.
