At that time the Bids received will be privately opened.

The Procurement includes the following Items:

Install 2,220 linear feet of 8" C900 DR-18 water line from the existing water treatment facility to the new Soldier Canyon Well No. 2. Installation includes all fittings and appurtenances, valves, connections to existing piping, trenching, backfill and restoration.

Bids will be received for the following Contract: Soldier Canyon Water Line.

Owner anticipates that Procurement's total bid price will be approximately \$150,000. Procurement has an expected duration of 45 days.
