**3. S.R. 3 Senate Resolution Regarding Animal Sheltering During Disasters(Plumb, J.)**

Sen. Jen Plumb presented the bill.

**Amendment 1**

1. Line 44 through 54:

44 risks, prevent abandonment of animals, and streamline evacuation and sheltering operations:  
45 NOW, THEREFORE, BE IT RESOLVED that the Senate of the state of Utah encourages  
46 all local governments in Utah to develop, update, or expand disaster emergency plans to  
47 include provisions addressing the needs of individuals with household pets{~~-consistent with-~~  
48 {federal guidance}}.  
49 BE IT FURTHER RESOLVED that the Senate of the state of Utah encourages local  
50 governments to coordinate with emergency management professionals, voluntary animal  
51 organizations, public health agencies, and community partners to {ensure}provide adequate sheltering  
52 and care standards for household pets during disasters.  
53 BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Utah Division  
54 of Emergency Management, each county commission or council, each municipal government,
