

Ordinance No. 26-02-19 A
An Ordinance of the Hinckley Town Council
2026 GENERAL PLAN

WHEREAS the Town Council of Hinckley, Utah, pursuant to the provisions of UCA 10-20-4 (as amended), has the authority to revise the plans and ordinances of the municipality;

WHEREAS the Town of Hinckley has recognized the need for comprehensive updates to its existing Town plans and policy for growth and development within and around the Town, ensuring alignment with contemporary needs and state mandates;

WHEREAS the Town Council and Planning Commission has reviewed the proposed revisions and has made such changes, alterations, modifications, additions, and substitutions as it deems best; and

WHEREAS the proposed plan includes updates to issues relevant to land use, housing, transportation, parks, and capital investment issues within the political boundaries and proposed annexation areas of Hinckley, reflecting the community's vision for sustainable growth and development.

WHEREAS the Planning Commission held a public hearing on Tuesday, February 17, 2026 before recommending the 2026 General Plan to the Town Council.

NOW, THEREFORE, be it ordained by the Town Council of the Town of Hinckley:

SECTION I: That the documents considered by the Town to serve as the Hinckley Town General Plan be adopted, effective immediately upon passage, and that all necessary actions be taken to implement these updates for the benefit of the Town's growth and development. This document shall be accepted in all courts without question as the official code and law of the Town as enacted by the Town Council.

SECTION II: If any provisions of the Town's code previously adopted are inconsistent herewith, they are hereby repealed.

SECTION III: This ordinance being necessary for the peace, health, and safety of the Town, shall become effective immediately upon posting.
