





# Road Width Discussion

---



Dear Fire Marshals:

Many years there are bills in the legislature that we do not like. We work through the process and try to accomplish the best law that we can. Some years are better than others, and some years laws are passed that we disagree with, and we will have difficulty enforcing them. A few years ago, a bill was passed establishing 32 feet as the maximum width of pavement we could require on a minor road. The home builders wanted 25 feet; the fire service wanted as much width as practical to facilitate firefighting operations.

Neither side was happy, but we compromised at 32 feet of pavement with certain exceptions for wider roads in specific circumstances that would reasonably require wider roads. Recently builders have expressed concerns citing cities that are ignoring the law relative to road widths or unreasonably using the exceptions to require wider roads. When a municipality chooses to misapply or ignore the law, they only encourage more legislation resulting in us fighting 25-foot-wide road widths again.

Fire response is often the reason given for requiring wider roads. Sometimes the fire official does not even know that their department is being used as the reason for a city requirement. Please comply with the agreement, and law, of 32 feet of pavement on minor roads in subdivisions. Please also encourage your city engineer, planning commission, and city council to comply with this law. A failure to comply will result in future legislation where we will be defending enough road width to effectively fight fire.





# INDIVIDUAL PARK IMPROVEMENTS

## » **Loy Blake Park:**

- » Redesign northwest corner of the park to create four-plex of baseball fields with updated concessions plaza, seating and pathways
- » Provide a perimeter pathway that also connects to parking lots, major amenities, and pathways within the park
- » Add more benches at the playground
- » ~~Replace picnic tables~~
- » Update the splash pad, include pavilions for shade (evaluate options for converting it to a recirculating system, or a system that treats and reuses the wastewater) (only built 3 years ago)
- » Evaluate the addition of lighting for sports fields and courts where appropriate

## » **Bingham Park:**

- » Add lighting for safety
- » Evaluate the addition of lighting for sports fields and courts where appropriate
- » Provide multi-sport/basketball courts similar to Loy Blake Park
- » Build more multi-purpose fields
- » Update the playground and replace sand with engineered wood fiber safety surfacing

## » **East Park:**

- » Plant more trees
- » Add a skate park/pump track
- » Add a dog park
- » Add park name signage
- » Consider additional passive recreation activities
