**A RESOLUTION OF THE CITY OF TAYLORSVILLE CONSENTING TO THE
APPOINTMENT OF BETSY VALORA AS A DEPUTY CITY RECORDER.**

WHEREAS, the Taylorsville City Council (the “Council”) met in a regularly scheduled session on March 4, 2026, to consider, among other things, consenting to the appointment of Betsy Valora as a Deputy City Recorder; and

WHEREAS, UTAH CODE ANN. §10-3-916(3) provides that the Mayor may appoint officers of the City, with the advice and consent of the Council; and

WHEREAS, the Mayor has determined that appointing a Deputy City Recorder is necessary to provide good government to the City’s citizens; and

WHEREAS, Kris Heineman, the City Council Coordinator and a sworn Deputy City Recorder retired in June 2025; and

WHEREAS, the Mayor has determined that it is necessary to appoint a new Deputy City Recorder to replace Kris Heineman in light of that retirement; and

WHEREAS, the Mayor hereby nominates Betsy Valora as a Deputy City Recorder; and

WHEREAS, the Council has given advice for such appointments and hereby consents to such appointments; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interest of the health, safety, and welfare of the City’s citizens to consent to the appointment of Betsy Valora as a Deputy City Recorder.

NOW, THEREFORE, BE IT RESOLVED that the Taylorsville City Council hereby consents to the appointment of Betsy Valora as a Deputy City Recorder.

This Resolution, assigned Resolution No. 26-04, shall take effect immediately upon passage and acceptance as required herein.
