Chairman Joe Allred introduced the revision of Title 15.11.210 regarding travel trailers. The revision includes penalties for property owners permitting violations. The enforcement will be handled by the Uintah County Law enforcement. The provision establishes regulations regarding the ownership and occupation of travel trailers, truck campers, and motor homes. It mandates that any owner or occupier of these vehicles, as well as any property owner who allows such violations on their property, shall be considered guilty of Class C misdemeanor if the violation is not rectified within 30 days of receiving notice. This offense carries a maximum fine of \$700.00 and the possibility of a jail sentence of up to 90 days.
