D. COMMISSIONER COMMENTS:

Commissioner Harvey: What a privilege to be able to have the 2034 Winter Games recognize Ogden and Weber County as local leaders including myself will meet in Italy with other host cities. We will take opportunities to share information in advance of the first Olympic test event, the 2026 World Curling Championships being held at the Ice Sheet, which has been extensively renovated. Our people here are good at this and we are ready. We have one of the highest volunteer counts per capita of anywhere else in the country.

Jim Retallick (Public Defender Director): These contractors supplement the work our full time attorneys do. Without them, we could not deliver our services to the indigent people in Weber County.

Chair Froerer: There are those in the Indigent Defense Council at the State who are impressed with what we have done in Weber County and use us as a model for the rest of the State. A number of people at the State value what Mr. Retallick does and what has been done in Weber County.

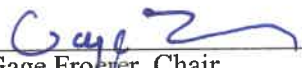

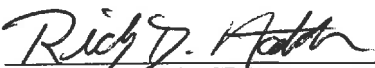
