D. COMMISSIONER COMMENTS:

1. Chair Froerer: I don't know if anyone has noticed but we are finally getting some snow, which is very much needed. I actually had not much more than a skiff of snow in Ogden Valley but it's the first white stuff we have had in a couple of months. We need snow in the mountains for our summer water supply so hopefully it keeps coming.

G. ACTION ITEMS:

1. **APPROVAL OF FIRST READING OF AN ORDINANCE AMENDING CHAPTER 2 OF THE WEBER COUNTY FEE ORDINANCE, SEC. 16-2-2 CLERK/AUDITOR FEES.**

Mona Wald (Clerk/Auditors Office): We are proposing to begin offering marriage services on a trial period for \$10 for the officiating and \$25 if witnesses from our office are needed. We do about 4k marriage licenses per year.

Chair Froerer: If this a trial basis, we may want to designate an area in the building renovation plans for these marriages.

Commissioner Bolos moved to approve First Reading of an Ordinance amending Chapter 2 of the Weber County Fee Ordinance, Sec. 16-2-2 Clerk/Auditor Fees; Chair Froerer seconded.

2. **APPROVAL OF FIRST READING OF AN ORDINANCE ALLOWING APPOINTMENT OF ADDITIONAL ALTERNATE MEMBERS TO THE GRAMA APPEALS BOARD.**

Courtlan Erickson (Attorney's Office): Ernie Gonzalez, our GRAMA Appeals Board Chair, is requesting flexibility to having additional alternate Board members to support GRAMA Appeals Board scheduling.

There have been occasions where a Board member had to cancel and alternate members were not available, leading to last minute cancellations. The Ordinance proposes changing wording from “appoint one alternate as a County employee and one alternate as a member of the public” to “at least one”, giving the Commission flexibility to appoint one or more alternates.

Commissioner Bolos moved to approve First Reading of an Ordinance allowing appointment of additional alternate members to the GRAMA Appeals Board; Chair Froerer seconded.

3. APPROVAL OF FIRST READING OF AN ORDINANCE AMENDING CERTAIN FEES TO THE WEBER COUNTY CULTURE, PARKS, AND RECREATION DEPARTMENT.

Brad Cragun (Parks and Recreation Director): Our department has a diverse range of services and facilities that we constantly monitor. We do this to make sure our fees are where they need to be and to adjust or eliminate fees structures to accurately reflect what we offer. Proposed changes reflect adding campsites to our campgrounds in North Fork and Memorial and removing classes that are no longer offered.

Commissioner Bolos moved to approve First Reading of an Ordinance amending certain fees to the Weber County Culture, Parks, and Recreation Department; Chair Froerer seconded.

4. APPROVAL OF RESOLUTION 08-2026 CREATING THE WEBER COUNTY PARAMEDIC AND TECHNICAL RESCUE COMMITTEE.

Lisa Schwartz (Emergency Management and Homeland Security Program Director): This is a Resolution to create the Paramedic and Technical Rescue Committee. This Committee will help enhance coordination and cooperation between Weber County and the fire agencies and enable us to do a better job with expenditures on program funding for supplies, equipment, and training.

Chief Britt Clark (Weber Fire District Chief): The County funds a few programs that are distributed between departments. This is a way for all agencies to have input on those programs and a way for them to help guide the Commission on those financial decisions. The Committee will be comprised of every Fire Chief in the County or their designees. The Committee will fall between the existing subcommittees.

Commissioner Bolos moved to approve Resolution 08-2026 creating the Weber County Paramedic and Technical Rescue Committee; Chair Froerer seconded.

5. APPROVE A MASTER SERVICES AND PURCHASING AGREEMENT WITH AXON FOR THREE BODY CAMERAS FOR WEBER COUNTY ANIMAL CONTROL OFFICERS.

Siri Main (Animal Shelter Director): Animal Control lacks accountability and transparency for the community. Though Animal Control officers are not sworn officers, we propose to provide them with body cameras, similar to other local animal control agencies. Funding will be pulled from the quartermaster budget. Long term funding will have to be addressed through a budget increase. There are future plans to purchase bullet proof vests with name tags.

Commissioner Bolos: This is a wise idea for full transparency and to protect both our animal control officers and the public. I really appreciate Siri and her diligence watching every dollar.

Commissioner Bolos moved to approve a Master Services and Purchasing Agreement with Axon for three body cameras for Weber County Animal Control Officers; Chair Froerer seconded with comment: the more transparent we can be with the public, the better.

6. APPROVE A CONTRACT WITH DIAMOND RENTAL TO LOCK IN PRICES OF CANOPIES THAT WILL BE PROVIDED FOR THE WEBER COUNTY FAIR FROM NOW UNTIL 2030.

Brad Cragun (Parks and Recreation Director): For several years, they have been splitting rentals between Diamond and Rocky Mountain Rental. Rocky Mountain came out this year with a high quote. Proposing a

five year agreement with Diamond Rental with a 3% yearly increase allowing for cost increases and inflation.

Commissioner Bolos moved to approve a contract with Diamond Rental to lock in prices of canopies that will be provided for the Weber County Fair from now until 2030; Chair Froerer seconded.
Chair Froerer – aye; Commissioner Harvey – excused; Commissioner Bolos – aye

7. APPROVE A CONTRACT WITH CALEA FOR ACCREDITATIONS AND STANDARDS USE.

Eli Johnson (Sheriff's Department, Homeland Security): This is an international accreditation body allowing access to trademarked and copyrighted standards over the next 36 months. Money was found from other budgets to pay for this contract.

Commissioner Bolos moved to approve a contract with CALEA for accreditations and standards use; Chair Froerer seconded.
