**A RESOLUTION AMENDING THE PERRY CITY POLICIES  
REGARDING RETIREMENT BENEFITS AND SERVICE AGREEMENT  
WITH UTAH RETIREMENT SYSTEMS**

**WHEREAS**, Perry City adopted the Perry City Policy Manual by resolution on February 27, 2025; and

**WHEREAS**, the Policy Manual is intended to be a working document, subject to regular review by the Mayor, City staff, and elected officials to ensure it remains current with applicable City, State, and Federal laws and procedures; and

**WHEREAS**, Perry City is an employer participating in the Utah Retirement System (URS); and

**WHEREAS**, URS has added new Roth 401(k) and Roth 457 savings plan options, which must be formally adopted by the City to allow employee participation; and

**WHEREAS**, Perry City desires to provide competitive and beneficial retirement savings options to its employees.

**NOW, THEREFORE**, be it resolved by the City Council of Perry City, Utah that:

1. Section 4.6 of the Perry City Policy Manual is hereby amended to include Roth 401(k) and Roth 457 savings plans as available employee benefits, as set forth in the proposed amended "401(k) and Other Retirement Plans" policy attached hereto as Exhibit A and incorporated herein by reference.
2. The Mayor and/or appropriate City officials are authorized to execute any required service agreements and related documents necessary to implement and effectuate these benefits through the Utah Retirement Systems.
