

**RESOLUTION NO. 07-2026**

**A RESOLUTION APPROVING AN INTERLOCAL COOPERATION AGREEMENT BETWEEN WEBER COUNTY AND WEBER FIRE DISTRICT FOR THE PROVISION OF PARAMEDIC SERVICES; AUTHORIZING EXECUTION OF THE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**SECTION 1 – RECITALS**

**WHEREAS**, Weber Fire District (the “District”) is a local district and a political subdivision of the State of Utah, duly organized and existing pursuant to Title 17B, Chapter 1, Local Districts, and Title 17B, Chapter 2a, Part 9, Fire Protection and Emergency Services Local District, of the Utah Code; and

**WHEREAS**, Weber County (the “County”) is a body politic and political subdivision of the State of Utah organized under Title 17, Counties, of the Utah Code; and

**WHEREAS**, the Interlocal Cooperation Act, codified at Title 11, Chapter 13, Utah Code, authorizes public agencies to enter into interlocal agreements for the cooperative provision of governmental services and to exercise jointly any power, privilege, or authority capable of exercise by a public agency of the State of Utah; and

**WHEREAS**, the Parties desire to enter into an Interlocal Cooperation Agreement for Paramedic Services for the purpose of furnishing and providing paramedic services to the area commonly known as the Upper Valley of Weber County, paramedic rescue services to the northwest portion of Weber County, and back-up paramedic rescue services to the remainder of the County; and

**WHEREAS**, paramedic services are governed by the Utah Emergency Medical Services System Act, codified at Title 53, Chapter 2d, Utah Code, including Parts 1 through 9 thereof, and applicable administrative rules promulgated thereunder; and

**WHEREAS**, the Agreement establishes a term beginning January 1, 2026, at 12:01 a.m., and continuing through December 31, 2030, at 11:59 p.m., unless earlier terminated in accordance with its terms; and

**WHEREAS**, the Board of Trustees finds that entering into the Agreement promotes the health, safety, and welfare of the citizens served by the District and is in the best interests of the District;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF WEBER FIRE DISTRICT, STATE OF UTAH, AS FOLLOWS:**

**SECTION 2 – APPROVAL OF AGREEMENT**

The Board of Trustees hereby approves the Interlocal Cooperation Agreement for Paramedic Services between Weber County and Weber Fire District pursuant to Title 11, Chapter 13, Utah Code, substantially in the form presented to the Board and incorporated herein by reference.

The Board Chair is authorized to execute the Agreement and any ancillary documents necessary to effectuate the Agreement. The District Clerk is authorized to attest the same and to ensure the Agreement is filed with the keeper of the records of the District as required by Section 11-13-209, Utah Code.

**SECTION 3 – GOVERNMENTAL IMMUNITY**

Nothing in this Resolution or the Agreement shall be construed as a waiver of any immunity, defense, or limitation of liability available to the District or the County under the Governmental Immunity Act of Utah, Title 63G, Chapter 7, Utah Code.

**SECTION 4 – REPEALER**

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict, including prior resolutions approving earlier paramedic service agreements with Weber County.

**SECTION 5 – SEVERABILITY**

If any section, provision, or portion of this Resolution is determined to be invalid or unenforceable, such determination shall not affect the validity or enforceability of any other portion of this Resolution, it being the intent of the Board of Trustees that the provisions of this Resolution are severable.

**SECTION VI. EFFECTIVE DATE.**

This Resolution shall take effect immediately upon adoption.
