**Welcome and Public Comment.** Trustees were welcomed to the January 12, 2026 Board Meeting.

**Approval of December 8, 2025, Public Hearing Minutes.** A motion to approve the Public Hearing minutes of December 8, 2025, was made by Trustee Gordon Cutler, seconded by Trustee Grover Wilhelmsen. Motion passed unanimously.

**Approval of December 8, 2025, Board Meeting Minutes.** A motion to approve the Board Meeting minutes of December 8, 2025, was made by Trustee Ryan Barker, seconded by Trustee Sallee Orr. Motion passed unanimously.

**December Budget Report.** Director Keith Hill reviewed the Monthly Budget Report. General Fund Expenditures in December totaled \$130,521.23 with no additional Capital Expenses, YTD expenses are at 86.94%. The Public Treasurer’s Investment Fund balance is \$2,537,816.17. The Bank of Utah checking account balance as of December 31, 2025, totaled \$230,333.95 and the America First CD earned \$630.10 in interest bringing the total to \$190,859.45.

**Approval of the Monthly Bills for December.** The Board proceeded to discuss the monthly bills. Keith explained check #20181 totaling \$5,439.70 to Bank of Utah for the District VISA and check #20189 in the amount of \$14,816 to VDCI for aerial spraying. A motion to approve the monthly bills for December was made by Trustee Jed Jenkins, seconded by Trustee Jim Harvey. Motion passed unanimously.

**Action: Board Elections – Chair, Vice Chair, District Clerk, & District Treasurer.** Trustee Steve Gibson nominated Trustee Gordon Cutler as the District Board Chair, seconded by Trustee Jim Harvey. Trustee Steve Gibson nominated Trustee Ryan Barker as the Vice Chair, seconded by Trustee Jim Harvey. Nominations were closed and the motion passed unanimously. Director Keith Hill will remain the District Treasurer and Office Manager Becky Bowcutt will remain the District Clerk.

**Director’s Report.** Director Keith Hill reminded Trustees that the February board meeting will be cancelled.

**Adjourn.** A motion to adjourn was made by Trustee Jim Harvey, seconded by Trustee Grover Wilhelmsen. Motion passed. The meeting adjourned at 6:20 pm.
