**AN ORDINANCE OF THE FARR WEST CITY COUNCIL
ADOPTING A PROJECT AREA PLAN**

WHEREAS, the Farr West City Community Reinvestment Agency (“Agency”) approved the Farr West Landing Community Reinvestment Agency Plan (“Plan”) with revisions as presented at a scheduled public meeting; and

WHEREAS, the Agency previously held a public hearing to allow public comment on the Plan;

WHEREAS, Utah Code Ann. § 17C-5-109 requires the proposed Plan to be presented to the legislative body for adoption via ordinance; and

WHEREAS, the proposed Plan approved by a resolution of the Agency under Utah Code Ann. § 17C-5-104 may not take effect until the community legislative body adopts the proposed Plan by ordinance and provides notice in accordance with Utah Code Ann. § 17C-5-110; and

NOW THEREFORE, in accordance with Utah Code Ann. §17C-5-109, the Farr West City Council does hereby adopt the Plan with revisions and further ordains as follows:

1. The proposed Farr West Landing Community Reinvestment Project Area Plan with any revisions is hereby incorporated by reference.
2. The Farr West Landing Community Reinvestment Agency Plan is the official plan of the community reinvestment project area.
3. Notice of the adoption of the Farr West Landing Community Reinvestment Agency Plan is hereby ordered to be published in accordance with Utah Code Ann. § 17C-5-110(1).
4. This Ordinance shall take effect upon passage and posting.

4. This Ordinance shall take effect upon passage and posting.


