9:05 JAMES D "MITCH" VILOS WAS ALLOCATED 5 MINUTES FOR HIS PRESENTATION.

MITCH'S PRESENTATION TO THE BOARD WAS ABOUT RESTORATION OF RIGHTS FROM OTHER STATES AND GAVE ACCOUNT TO THE BOARD THAT THEY CAN AUTHORIZE AND HAVE THE AUTHORITY TO OVERTURN A DENIAL THROUGH THE STATE OF UTAH. MITCH SUBMITS EXHIBITS TO THE BOARD MEMBERS.

CHRISTOPHER SIMPSON-AFTER BEING SWORN IN AGENT MARSHALL READ THE DISPOSITION, ON DECEMBER 16TH 2025 MR. SIMPSON'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON A DECEMBER 5TH 1995, FELONY CONVICTION INVOLVING ASSAULT IN THE STATE OF OREGON. AFTER THE REVIEW OF ALL THE DOCUMENTS IN THE FILE AND MR SIMPSON TESTIMONY, OF WORKING THROUGH PROGRAMS AND THE TIME OF PROBATION MICHELLE MOTIONS TO OVERTURN THE DENIAL, JEREMY SECONDS THE MOTION ALL IN FAVOR.

MICHAEL SALGADO- AFTER BEING SWORN IN AGENT MARSHALL READ THE DISPOSITION, ON NOVEMBER 24TH 2025, MR. SALGADO'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON NOVEMBER 14TH 2018 CONVICTION FOR CRIMINAL MISCHIEF (INVOLVING DOMESTIC VIOLENCE) IN THE STATE OF UTAH. MR. SALGADO STATED THIS WAS AN ONGOING PROBLEM WITH THE EX-WIFE, ALSO HAD SWORN IN HIS SON TO TESTIFY AGAINST ALL THE WRONG INFORMATION MR SALGADO WAS ACCUSED OF. AFTER REVIEW OF ALL THE DOCUMENTS AND STATEMENTS, MICHELLE MOTIONS TO OVERTURN THE BOARD, JEREMY SECONDS THE MOTION, ADAM, RAWLIN AND JARED WERE NOT IN AGREEMENT SO THE MOTION WAS DENIED NOT ALL IN FAVOR. MOTION TO UPHOLD THE DENIAL STANDS.

LUIS DEL RIO - AFTER BEING SWORN IN AGENT MARSHALL READ THE DISPOSITION, ON AUGUST 6TH, 2025 MR. RIO'S CONCEALED FIREARM PERMIT WAS REVOKED BASED ON A JULY 29TH 2025, CONVICTION FOR DISORDERLY CONDUCT (INVOLVING DOMESTIC VIOLENCE). THE BOARD READ ALL THE DOCUMENTS IN THE FILE AND INDICATED THIS WAS NOT A DOMESTIC VIOLENCE CHARGE THIS WAS A DISORDERLY CONDUCT CLASS C MISDEMEANOR AND NEEDED TO COMPLETE HIS PROBATION. JARED MOTIONS TO UPHOLD THE REVOCATION, ADAM SECONDS THE MOTION ALL IN FAVOR MOTION TO UPHOLD THE REVOCATION THROUGH THE STATE OF UTAH.

CARDO HERNANDEZ- AFTER BEING SWORN IN SPECIALIST LINDQUIST READ THE DISPOSITION, ON OCTOBER 2ND, 2025 MR. HERNANDEZ'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON AN APRIL 8TH 2008 FELONY CONVICTION INVOLVING FORCE/ADW NOT FIREARM GBI LIKELY IN THE STATE OF CALIFORNIA. AFTER READING ALL THE DOCUMENTS IN THE FILE AND TESTIMONY FROM MR HERNANDEZ THE BOARD HAD MENTIONED THE PROBATION STILL IN IN PLACE AND NEEDS TO HAVE THE CHARGE REDUCED FROM A FELONY TO A MISDEMEANOR. JARED MOTIONS TO UPHOLD THE DENIAL, RAWLIN SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

GABRIEL HAYON-AFTER BEING SWORN IN SPECIALIST LINDQUIST READ THE DISPOSITION, ON AUGUST 26TH 2025, MR HAYON'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON A DECEMBER 20TH, 2024 ALCOHOL RELATED CONVICTION INVOLVING DRIVING UNDER THE INFLUENCE, THROUGH THE STATE OF COLORADO. AFTER REVIEW OF ALL THE DOCUMENTS IN THE FILE AND TESTIMONY THE BOARD HAD MENTIONED THAT THE PROBATION STILL IS IN PLACE AND WOULD NEED TO HAVE THAT MET. RAWLIN MOTIONS TO UPHOLD THE DENIAL, ADAM SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

YAD KHOSHNAW- - ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON JULY 7TH, 2025 MR KHOSHNAW'S UTAH CONCEALED FIREARM PERMIT WAS SUSPENDED BASED ON A JULY 3RD, 2025 ALCOHOL RELATED CONVICTION, WITH A PLEA IN ABEYANCE INVOLVING RECKLESS DRIVING THROUGH THE STATE OF UTAH. AFTER ALL THE DOCUMENTS WERE REVIEWED BY THE BOARD STILL NEEDS TO MEET THE PROBATION REQUIREMENTS, JARED MOTIONS TO UPHOLD THE SUSPENSION, ADAM SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE SUSPENSION THROUGH THE STATE OF UTAH.

BRYAN WILD-ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON OCTOBER 28TH 2025, MR. WILD'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON JUNE 18TH 2024 ALCOHOL RELATED CONVICTION INVOLVING OPEN CONTAINER THROUGH THE STATE OF UTAH. THE BOARD READ ALL THE DOCUMENTS IN THE FILE. MICHELLE MOTIONS TO UPHOLD THE DENIAL, ADAM SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH

DUANE S DOYLE - ABSENTIA- SPECIALIST LINDQUIST READ THE DISPOSITION, ON SEPTEMBER 29TH, 2025. MR DOYLE'S UTAH CONCEALED FIREARM PERMIT RENEWAL APPLICATION WAS DENIED BASED ON FALSIFICATION OF THE CONCEALED FIREARM PERMIT APPLICATION AND CONVICTION OF A CRIME OF VIOLENCE. MR. DOYLE HAD BEEN CHARGED AND LATER CONVICTED OF THREAT TO USE A DANGEROUS WEAPON IN A FIGHT IN UTAH ON MAY 20, 2021. MR. DOYLE DID NOT ANSWER THE APPLICATION QUESTION ABOUT THE CONVICTION OF A CRIME OF VIOLENCE TRUTHFULLY WHEN HE SAID "NO". MICHELLE MOTIONS TO UPHOLD THE DENIAL, RAWLIN SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

LILLIAN MARTINEZ- ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON SEPTEMBER 10TH 2025, MS. MARTINEZ'S UTAH CONCEALED FIREARM PERMIT WAS SUSPENDED BASED ON JULY 15TH 2025 NCIC WEAPONS PROHIBITED PROTECTION ORDER THROUGH THE STATE OF CONNECTICUT. AS OF JANUARY 12TH 2026, THE PROTECTION ORDER IS STILL IN PLACE. AFTER READING ALL THE DOCUMENTS IN THE FILE, JARED MOTIONS TO UPHOLD THE SUSPENSION ALL IN FAVOR TO UPHOLD THE SUSPENSION THROUGH THE STATE OF UTAH.

DONMONTA HAYES-ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON OCTOBER 28TH 2025 MR. HAYE'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON A DECEMBER 22ND, 20089 FELONY CONVICTION INVOLVING ROBBERY IN THE STATE OF CALIFORNIA. THE BOARD READ ALL THE DOCUMENTS IN THE FILE STILL SHOWING A FELONY CONVICTION, MICHELLE MOTIONS TO UPHOLD THE DENIAL, JEREMY SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

MARIO VALLECILLO- ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON OCTOBER 1ST, 2025 MR. VALLECILLO'S UTAH CONCEALED FIREARM PERMIT WAS SUSPENDED BASED ON A FEBRUARY 2ND 2025 NICS INDEX ENTRY AS A FEDERALLY DENIED PERSON THROUGH THE STATE OF MASSACHUSETTS. AFTER REVIEW OF ALL THE DOCUMENTS IN THE FILE MICHELLE ASKED THE AGENT IF THE CHARGE WERE STILL SHOWING ON THE RECORD, AGENT LINDQUIST RAN THE NICS FILE AGAIN TO FIND THAT IT IS STILL SHOWING MR VALLECIOLO WAS A DENIED PERSON, MICHELLE MOTIONS TO UPHOLD THE SUSPENSION, JEREMY SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE SUSPENSION THROUGH THE STATE OF UTAH.

DALE SEAGLE-ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON SEPTEMBER 8TH 2025, MR. SEAGLE'S UTAH CONCEALED FIREARM PERMIT WAS REVOKED DUE TO AUGUST 20TH 2025, CONVICTION FOR DISTURBING THE PEACE (INVOLVING DOMESTIC VIOLENCE) IN THE STATE OF IDAHO. THE BOARD READ ALL THE DOCUMENT IN THE FILE AND THE CHARGE STILL REMAINS AS DV. ADAM MOTIONS TO UPHOLD THE REVOCATION, JEREMY SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE REVOCATION THROUGH THE STATE OF UTAH.

DEMETRIUS MENSAH-ABSENTIA- AGENT MARSHALL READ THE DISPOSITION, ON SEPTEMBER 9TH 2025 MR. MENSAH'S UTAH CONCEALED FIREARM PERMIT WAS SUSPENDED BASED ON AN AUGUST 25TH 2025 NICS INDEX ENTRY AS A FEDERALLY DENIED PERSON (CONTROLLED SUBSTANCE USER) THROUGH THE DEPARTMENT OF THE ARMY. THE BOARD READ ALL THE DOCUMENTS IN THE FILE AND THE NICS HIT WILL NOT EXPIRE UNTIL JUNE OF 2026. MICHELLE MOTIONS TO UPHOLD THE SUSPENSION, JARED SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE SUSPENSION THROUGH THE STATE OF UTAH.

ROSSI TREADWELL -ABSENTIA- SPECIALIST LINDQUIST READ THE DISPOSITION, ON SEPTEMBER 11TH 2025 MR. TREADWELL'S UTAH CONCEALED FIREARM PERMIT RENEWAL WAS DENIED BASED ON FALSIFICATION OF THE CONCEALED FIREARM PERMIT APPLICATION AND ALSO CONVICTION OF A CRIME OF MORAL TURPITUDE. MR TREADWELL HAD BEEN CHARGED AND LATER CONVICTED OF FLEEING LAW ENFORCEMENT ON SEPTEMBER 16, 2024; MR. TREADWELL DID NOT ANSWER THE APPLICATION QUESTION ABOUT THE CONVICTION OF CRIME OF A MORAL TURPITUDE TRUTHFULLY WHEN HE SAID NO. MICHELLE MOTIONS TO UPHOLD THE DENIAL, JARED SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

JASON HARRICHARAN-ABSENTIA- SPECIALIST LINDQUIST READ THE DISPOSITION, ON JUNE 12TH 2025 MR. HARRICHARAN'S UTAH CONCEALED FIREARM PERMIT WAS DENIED BASED ON AN OCTOBER 23RD, 1998 FELONY CONVICTION INVOLVING CRIMINAL POSSESSION STOLEN PROPERTY IN THE STATE OF NEW YORK. THE BOARD REVIEWED ALL THE DOCUMENTS IN THE FILE. THERE IS A RESTORATION OF RIGHTS IN THE FILE BUT WOULD NEED MORE DOCUMENTS TO BE CONSIDERED. MICHELLE MOTIONS TO UPHOLD THE DENIAL, ADAM SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE DENIAL THROUGH THE STATE OF UTAH.

NATHANIEL JOHNSON- ABSENTIA - INSTRUCTOR LICENSE SUSPENSION- SPECIALIST LINDQUIST READ THE DISPOSITION, ON JULY 7TH MR. JOHNSON'S INSTRUCTOR STATUS WAS SUSPENDED, THE BOARD READ IN THE FILE THAT HE HAD SEVERAL PEOPLE REACHING OUT STATING HE WAS NOT TEACHING THE UTAH LAW AND HIS COURSE WAS ONLY 2 HOURS LONG. MICHELLE MOTIONS TO UPHOLD THE SUSPENSION, ADAM SECONDS THE MOTION ALL IN FAVOR TO UPHOLD THE INSTRUCTOR SUSPENSION THROUGH THE STATE OF UTAH.
