

**ORDINANCE 26- 05**

**AN ORDINANCE ADOPTING AMENDMENTS TO THE NORTH LOGAN CITY  
MUNICIPAL CODE – VARIOUS SECTION CORRECTIONS**

1           WHEREAS, the City Council of the City of North Logan, Utah, adopted and passed the Code of  
2 Revised Ordinances of the City of North Logan on March 16, 1989, which Code was published and effective  
3 on 3 March 20, 1989; and

4           WHEREAS, the City Council of North Logan City, Utah, finds it necessary and appropriate to  
5 amend certain sections of the North Logan City Municipal Code to correct or clarify the code for the public  
6 welfare of its residents; and

7           WHEREAS, these amendments are necessary to ensure that city staff have the proper tools to  
8 respond to community concerns, and uphold the integrity of the municipal code.

9           NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF NORTH LOGAN  
10 CITY, UTAH, AS FOLLOWS (highlighted portions added, crossed through items deleted):

11 **SECTION I:** Title 6, Section 504(A)(2) is hereby modified as follows:

12 **6-504 Procurement Procedures**

13       2. Compliance with / Exemption from this policy.

14       a. This policy shall not prevent North Logan City from complying with the terms and conditions of  
15 any grant, gift, or bequest that is otherwise consistent with law.

16       b. When procurement involves the expenditure of federal assistance funds, North Logan City shall,  
17 as required, comply with applicable federal law regulations.

18       i. Federal programs will have one member of the upper management responsible for the project.  
19 That individual will be responsible for all aspects of the reporting and accumulation of  
20 information as well as the compliance requirements of the federal funds.

21 **SECTION II:** Title 6, Section 505 is hereby modified as follows:

22 **6-505 Accounting Guidelines**

23 It is recognized by the city council that North Logan City is required to use generally accepted accounting  
24 principles as part of the city financial administration. The following specific guidelines shall be used by  
25 the city where discretion is allowed within generally accepted accounting principles.

26       A. Capital Expenditures. Only expenditures that are greater than ~~\$3,000.00~~ **\$5,000.00** shall be classified  
27 as capital expenditures for accounting purposes for all funds in the city.

28 **SECTION III:** All North Logan City ordinances, resolutions, or parts thereof inconsistent herewith are  
29 hereby repealed to the extent of such inconsistency.

30 **SECTION IV: CONFLICT.** To the extent of any conflict between this ordinance and any other North  
31 Logan City ordinance(s) or regulation(s), the provisions of this Ordinance shall be controlling.

32 **SECTION V: SEVERABILITY.** The sections, paragraphs, sentences, clauses, and phrases of this  
33 Ordinance are severable. If any such section, paragraph, sentence, clause, or phrase shall be declared  
34 invalid or unconstitutional by the valid judgment or decree of a Court of competent jurisdiction, such  
35 invalidity or unconstitutionality shall not affect the validity or constitutionality of any of the remaining  
36 sections, paragraphs, sentences, clauses, or phrases of this Ordinance.

37 **SECTION VI: EFFECTIVE DATE.** In the opinion of the City Council of North Logan, it is necessary  
38 that this ordinance take effect immediately; therefore, this Ordinance shall take effect immediately upon  
39 its passage and first posting as provided by law.
