SUMMARY:	<p>The City must hold a public hearing 30 days prior to approving funding allocations for the upcoming 2026-2027 CDBG and HOME grant program year. A summary of applications received, as well as the Mayor’s funding recommendations, are provided below. Taylorsville anticipates receiving approximately \$351,000 in CDBG funding; formal action to approve allocations is scheduled for May 6 or May 20, 2026.
