

ORDINANCE NO. 26-17

AN ORDINANCE AMENDING THE 2009 WEST JORDAN CITY CODE
Title 6, Chapter 3D, Section 11 - SALE OF ANIMALS

WHEREAS, the City of West Jordan (“City”) adopted West Jordan City Code (“City Code”) in 2009; and the City Council of the City (“Council” or “City Council”) desires to amend Title 6, Chapter 3D, Section 11 of the City Code (“proposed City Code amendments”); and

WHEREAS, the City Council desires to amend the regulations covering the sale of pet animals in the City; and

WHEREAS, the City Council desires to ensure for the safety and health of the animals and consumer protection; and

WHEREAS, the City Council finds it to be in the best interest of the public health, safety, and welfare of the residents of the City to adopt the proposed City Code amendments.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:


Section 1. Amendment of City Code Provision. City Code Title 6, Chapter 3D, Section 11 is amended as shown in Attachments 1 (Legislative Version) and 2 (Clean Version) to this Ordinance.

Section 2. Severability. If any provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, the remainder shall not be affected thereby.

Section 4. Effective Date. This Ordinance shall become effective immediately upon posting or publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.

1 **6-3D-11: SALE OF ANIMALS:**

2 ~~—A. Rabbits Or Fowl: It shall be unlawful for any person to sell, offer for sale, barter or~~
3 ~~give away any baby rabbits or fowl under two (2) months of age in any quantity less than~~
4 ~~six (6). Such animals shall not be artificially dyed or colored. Nothing in this provision shall~~

6-3D-11: SALE OF ANIMALS:

- A. It is unlawful for any person to transfer to another by gift, sale, or exchange for any consideration any dog or cat in or upon any sidewalk, street, alley, public right of way, park or other public place.
- B. Pet shop requirements
 - 1. For each dog or cat sold, a pet shop shall make available upon request, the following information:
 - a. The name, city, and contact information of the animal's breeder;
 - b. The animal's date of birth;
 - c. A summary of the animal's health certificate or veterinary examination, along with any health guarantees provided at sale.
- C. It is unlawful for a dog to be sold before it has reached the age of eight weeks old.
- D. This section does not apply to livestock and does not regulate the sale of dogs or cats by a breeder on the premises where the animals were bred and reared.
