## EXECUTIVE SUMMARY

Through the 2024 Utah legislative session, H.B. 301 created a new mechanism allowing for the control and operation of a charter school to be transferred from a charter school governing board to the governing board of another charter school or of a nonprofit corporation. Specifically, Utah Code Title 53G, Chapter 5, Part 5, Section 502(8) reads as follows:

*A charter school governing board that has not entered into a school improvement process may voluntarily provide a proposal to the authorizer for consideration of transferring operation and control of the charter school to:*

- a. The school district in which the charter school is located;*
- b. The governing board of another charter school;*
- c. A private management company; or*
- d. The governing board of a nonprofit corporation.*

Pursuant to and in accordance with 53G-5-502, Endeavor Hall wishes to transfer the operation and control of their charter school to another charter school governing board, namely, Canyon Grove Academy.

**CONTEXT OF THE SCHOOLS**

Endeavor Hall is a 501(c)(3) tax exempt non-profit corporation and was granted a charter to open Endeavor Hall beginning with the 2011-2012 school year.

Endeavor Hall is located in West Valley City, Utah in the Granite School District. The mission of Endeavor Hall is: “Endeavor Hall serves students desiring to acquire superior writing skills in the context of an academically challenging curriculum in preparation for success in collegiate studies, careers, and civic communications.” Endeavor Hall is a free, public charter high school that provides education to students in grades K through 6.

Quail Run Primary School Foundation, dba Canyon Grove Academy (“Canyon Grove”) is a public charter school educating roughly 1,198 students. Canyon Grove offers hybrid learning through digital and non-digital, synchronous and asynchronous, both on-campus and off-campus. The mission of Canyon Grove is to be an inspired community of learners, parents, and educators who find fulfillment and joy in pursuing excellence in learning, self-accountability, and in meeting unique individual needs in order to prepare students for the life-long pursuit of knowledge to attain their potential. The school currently serves grades K-12.

## **BASIS FOR THE TRANSFER**

Endeavor Hall has concluded that transferring the operation and control is imperative for the continuation of its educational mission.

## **DETAILS OF THE TRANSFER**

If a transfer is approved by the Utah State Charter School Board, Canyon Grove will engage its legal counsel to draft legal documents effectuating the transfer. The documents will include the following details:

- a. An amendment to Endeavor Hall’s charter to effectuate the new governance structure of the school, including a list of the charter school governing board members and any necessary updates to reflect the transfer of operation and control.
- b. Approval from Endeavor Hall’s authorizer to transfer Endeavor Hall’s charter to Canyon Grove.
- c. All assets held by Endeavor Hall will inure to Canyon Grove. This includes, but is not limited to, equipment, furnishings, financial reserves, and any intellectual property rights owned or licensed by Endeavor Hall.
- d. Canyon Grove agrees to assume all existing employee contracts and Endeavor Hall’s current contract with Red Apple Financial for the term remaining on each contract. Certain other identified agreements made by Endeavor Hall will transfer to Canyon Grove at Canyon Grove’s sole discretion. For all assumed contracts and agreements, Canyon Grove will assume responsibility for fulfilling these agreements and will ensure continuity of services.
- e. Canyon Grove will develop a comprehensive plan for the transition of certain identified employees, including staff contracts, benefits, and any necessary training or orientation for employees transitioning to Canyon Grove, as determined in the sole discretion of the Canyon Grove Board of Directors (the “CGA Board”).
- f. The parties will each ensure compliance with all regulatory requirements related to the transfer.
- g. Each party obtains and provides the necessary board approvals and corporate resolutions agreeing to any transfer agreement reached to by the parties.

- h. The parties will deliver the transfer documents to the SCSB and appropriate departments of the State as directed to notify them of the transfer and to request dissolution of Endeavor Hall. Therefore, all financial, academic, and any other reporting will fall under the Canyon Grove identifier at any and all State offices.
- i. The Parties anticipate that the due diligence will be completed with a final agreement closing on or before June 30, 2026.

**OUTLOOK**

Endeavor Hall is currently expecting to enroll 245 students for the 2026-2027 school year. Canyon Grove has already prepared an outreach plan that addresses a variety of ways to market to students to increase enrollment for the 2026-2027 school year.

**APPROVAL**

This proposal has been approved by the governing boards of Canyon Grove and Endeavor Hall.
