**Financial Update**

2026 Actuals vs Budget

- 1 month into the year at 8.3% of the year. Total Revenues: 11% of total budget. Total Expenditures: 8% of total budget.

**Water Hauling Rule update and considerations on amending or eliminating the rule**

After the work meeting the health department realized there are couple of conflicts that have been created in the rule. We want to get the boards opinion for moving forward and included in the hearing.

- Current rule: applies to individual wells and small, mostly remote systems. DEQ takes care of anything that has more than 8-14 connections.
- Apply for septic permit -> Septic Requirements in State Rule -> Permit

With the elimination of the water hauling the non-public drinking water rule for Southwest Utah.

- Will affect 4.0 Approved potable water supply required.
  - 4.1.3 would need to be removed with water hauling being removed or
  - If there is a water system or a well available within so many feet with approved water rights you must connect to the well. Water hauling should be a last resort.
  - Create a standardize form that each county must fill out and submit to the health department.
  - Effective date for county ordinances would be 3 months after the updated non-public drinking water regulation is approved.
- Will affect 3.0 General Powers and Duties
  - 3.1.2 would need to be removed. This would allow the health department to say water is needed, but no verification.

Dr. Blodgett is recommending if 6.0 water hauling is removed then the entire non-public drinking water regulation should probably be repealed as well.

Suggestion:

- Health Department still issues the septic permit and collects fees. Maintain the responsibility for the water source of initial testing of wells as a requirement for the septic permit. An asterisk would be included on the septic permit stating a letter from the county has been received that the water hauling source has been approved.

4.1.3 updated to state “The building is to be serviced by water hauling as approved, and verified by the county within which the property is located.”

**Legislative Update**

- HB 22 – Exempt old cars from passing air quality
- HB 88 – Law that would require verification of lawful presence of certain public assistance benefits. This could affect several of our programs...WIC & Immunizations.
- ADA requirements for government websites and requirements for mapping data
- HB 152 – Education vaccine exemption amendments - Failed to pass out of committee
- 3 bills dealing with raw milk. The one that seems to be moving forward the best is HB 179.
- HB 229 – Fund created for tax of e-cigarettes. Remove the requirement that the fee comes to LHD for enforcement.
- HB 338 – cold plunge wants to expand the size. LHDs suggesting meet all the requirements except temperature.
- HB 337 – proposes \$6 per pack on tax. Not sure where the tax goes.
- HB 379 - Remove the requirements for inspecting daycare center for kitchens. Move it to a separate rule for state licensing.
