Cedar Mountain Service District Minutes March 4, 2026 Emergency Meeting

Agenda:

The Emergency Meeting was called to open and approve the Dust bids. This was necessary because the bids, which were specified in the RFP Notice to be opened during the March 2026 Board Meeting, were not included as a properly noticed agenda item for the Board meeting.

Dust Bid Opening

Companies from Virginia, Florida, Nevada and Idaho inquired about the FRP and parameters. One sealed bid from Idaho company Road Solutions was received. Bid received from Sharee Fassett and dated February 2, 2026 was opened and read by Zach Hascall: product cost \$122.98/ton, freight and application cost \$69.08/ton. Total cost delivered and applied totaled \$192.06 compared to \$162.23 in 2025. Resulting in an overall price increase of 15.5%. The current Dust fund balance is \$371k and the 2026 budgeted expense is \$373k. The same amount of product would cost approximately \$340k in 2026 compared to the total cost of \$294,374.38 in 2025.

The Board members discussed the lack of ability to build overall funds going forward. The 2026 Dust fee was increased to \$125 to account for 5% increase year over year for 3 years. Options for proceeding included pursuing other contractors for competitive bids, reducing the level of service and/or product, and the risk of losing tentative dates on the calendar. Overall the discussion leaned toward completing the service.

Scott Bowen made a motion to approve the bid from Road Solutions dated February 2 2026 for \$122.98/ton of product, \$69.08/ton freight/application and fuel surcharge to be applied.

Zach Hascall seconded the motion.


All were in favor, none opposed, motion carried unanimously.
