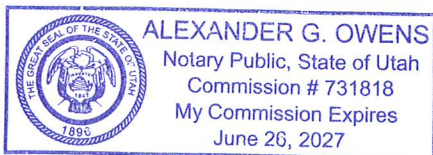

I, Tom Willis, am the duly appointed Chair of Sage Creek Infrastructure Financing District.

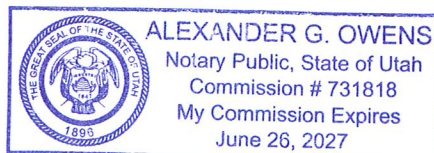
