1. Ash Creek Special Service District – Mike Chandler
Mike gave a presentation on the history of ACSSD, outlining its operations, services, current initiatives, and future growth. Mike reviewed the facilities currently in use within the area and explained their purposes. Mike answered questions from the council and staff regarding reuse water and systems in Toquerville.


The Council moved out of a closed session at 8:40pm

K. ADJOURN:


Mayor Catlin adjourned the meeting at 8:41pm.
