### MINUTES

#### CALL TO ORDER, PLEDGE OF ALLEGIANCE

The Planning Commission meeting was called to order at 6pm by Chairman Farrar, followed by the Pledge of Allegiance.

#### ROLL CALL, PRESENT

Chairman Bradley Farrar, Commissioner Lee Fralish, Commissioner Garth Hood, Commissioner Stewart Riding, and Commissioner Dan Harsh.

#### CONFLICT OF INTEREST DISCLOSURES

No conflicts of interest were disclosed.

Prior to opening the public hearings, it was announced that agenda items, 1, 3, 6, and 8 were removed at the request of the Mayor to allow for further discussion with the applicant. The Commission then proceeded with the remaining items.

## DISCUSSION AND POSSIBLE ACTION ITEMS

6. Ordinance O-2026-11, Zone Change Application, Current Zone: Agricultural Zone (A-X), Proposed Zone: Agricultural Five Acres (A-5), Project location: AV-1328-A, Daybreak Mesa Dr and Main Street.

Removed from agenda.

7. Simple Lot Subdivision Application for AV-1365-J, creating two new parcels.

The Commission reviewed the simple lot subdivision application for AV-1365-J. Discussion focused on the placement of a public utility easement and whether it would require coordination with a neighboring property owner. It was determined that the easement could be shifted entirely onto the applicant's property to avoid delays. Clarification was also provided regarding access to the property and road design requirements.

**MOTION:** Chairman Farrar moved to approve the Simple Lot Subdivision Application for AV-1365-J, pending the easements and road situation is figured out, and all the roads are designed to meet town specifications and standards and all the improvements.

The applicant's engineer inquired whether the approval constituted final approval or if further review by the Town Council was required. The Commission clarified that once the updated record of survey reflecting all required elements was submitted and signed off, the applicant could proceed to record the subdivision with the County. It was further clarified that an excavation permit would be required for any associated work, and that all required improvements must be completed prior to recording the subdivision.

8. Simple Lot Subdivision Application for AV-1328-A, creating seven new parcels.

Removed from agenda.

9. Preliminary Site Plan Application for Oculita Roca Resort, De La Tierra Holdings LLC.

The Commission reviewed the preliminary site plan application for the Oculita Roca Resort. The Mayor presented updates to the project, including adjustments to the layout of cabins to increase open space, which resulted in a reduction in the number of residential lots. Commissioners asked questions regarding road design, including whether curbs and gutters would be required. It was clarified that

most roads would include pavement with bar ditches rather than curb and gutter, and that some roads would be designated for emergency access. Additional discussion addressed lot sizes and septic system considerations.

**MOTION:** Commissioner Hood moved that we approve the Preliminary Site Plan Application for Oculita Roca Resort, De La Tierra Holdings LLC.

The Commission considered Ordinance O-2026-12, which proposed amendments to the Rural Estates Zone. The Mayor explained the changes, including adjustments to setback requirements and revisions to regulations regarding chickens and roosters on qualifying properties. Minor corrections to the ordinance text were also noted.

**MOTION:** Commissioner Riding moved to recommend approval of O-2026-12, Amend Title 10.10.050 RE Rural Estates Zone.
