This plan is required by the U.S. Department of Housing & Urban Development and must be approved prior to BRAG receiving their allocation of the State Small Cities Community Development Block Grant (CDBG) program funding.

Information provided at the public hearing includes a summary of the history of this program in the BRAG region and the draft of the Annual Action Plan.
