

**CHIEF TOQUER RESERVOIR
RECREATION COMMITTEE**

A. CALL TO ORDER – 3:00 PM

Mayor Catlin called the meeting to order at 3:00pm. The committee moved on to member introductions.

B. APPROVAL OF AGENDA:

1. The Committee reviewed the agenda.

D. PRESENTATION:

1. Corey Cram, Washington County Water Conservancy District

Corey Cram from the water district presented an overview of the history of the Chief Toquer Reservoir. He shared background on the project, including prior committees, the origin of the reservoir's name, and the studies and permitting processes involved. Corey also discussed recreation ideas that have been previously considered. Following his presentation, Mayor Catlin briefly summarized the committee's purpose.

E. BUSINESS:

1. **Discussion and possible appointment** of a Committee Chairperson.

Mayor Catlin noted that the Chief Toquer Reservoir Recreation Committee was established by resolution and that the committee must vote to appoint a chairperson. Lynn Olds nominated Mike Walker for the position, and Mike Walker accepted.

Lynn Olds nominated Mike Walker as the chairperson for the Chief Toquer Reservoir Recreation Committee. Motion passed 6-0. Dan Catlin – aye, Lynn Olds – aye, Mike Walker – aye, Corey Cram – aye, Bailey Guthrie – aye, Jack Alexander – aye.

2. **Discussion and possible approval** of Committee Goals and Objectives
Mayor Catlin reviewed the proposed Committee Goals and Objectives with the committee members. No action was taken on this item.
3. **Discussion and possible approval** of meeting schedule through September 2026.
