Once the County Auditor has closed the sale of a particular parcel of property as a result of accepting a bid on the parcel, the successful bidder or purchaser of the property may not unilaterally rescind the bid. The County legislative body, after acceptance of a bid, may enforce the

terms of the bid by obtaining a legal judgement against the purchaser in the amount of the bid, plus interest and attorney's fees, Section 59-2-1351.1.

Keep in mind that the sale is a "**buyer beware**" sale. If you purchase the property, you will later be provided with a recorded Tax Deed, which is similar to a Quit Claim Deed. It is your obligation to have researched each property you're interested in.
