RESOLUTION No. 2026-12

A RESOLUTION TENTATIVELY ADOPTING A TENTATIVE BUDGET
FOR THE PERIOD OF 1 JULY 2026 THROUGH 30 JUNE 2027;
PROVIDING FOR PUBLIC INSPECTION OF SUCH BUDGET;
ESTABLISHING THE TIME AND PLACE OF PUBLIC HEARING
TO CONSIDER ADOPTION OF SUCH BUDGET; AND PROVIDING
FOR PUBLICATION OF SUCH PUBLIC HEARING

WHEREAS, Part 5 of Chapter 13 of Title 11, UTAH CODE ANNOTATED, entitled “Fiscal Procedures for Interlocal Entities” (the “*Act*”), provides, among other things, that (a) the budget officer of an interlocal entity shall prepare and file with the entity’s governing body a tentative budget for the upcoming fiscal year; (b) the entity’s governing body shall review, consider (and amend, as advisable) and adopt such tentative budget; (c) the entity’s governing body shall hold a public hearing concerning the tentative budget following at least seven days’ prior “Class A” noticing under UTAH CODE ANN. 63G-30-102(1); and (d) following such public hearing, the entity’s governing body may adopt a final budget as provided in the Act; and

WHEREAS, at a meeting of the governing body (the “*Board*”) of the Central Wasatch Commission (the “*CWC*”) on 4 May 2026, Samantha Kilpack, the CWC’s budget officer, filed with the Board a tentative budget for the CWC for the period of 1 July 2026 through 30 June 2027 as required by the Act; and

WHEREAS, as part of its 4 May 2026 regular meeting, the Board reviewed and considered the proposed tentative budget (the “*Budget*”) for the CWC’s 2026-2027 fiscal year; and

WHEREAS, the Board desires to fully comply with the requirements of the Act regarding adoption of a final budget for the CWC for its 2026-2027 fiscal year; and

WHEREAS, after careful consideration, the Board has determined that it is in the best interest of the CWC to tentatively adopt the Budget as presented by the CWC’s budget officer, a photocopy of which is attached hereto;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Central Wasatch Commission that the Board hereby (a) tentatively adopts the Budget; (b) orders that a public hearing (the “*Hearing*”) concerning the Budget be held on 22 June 2026, beginning at 3:30 p.m., or as soon thereafter as practical, at Our Lady of the Snows Center 10185 E Highway 210, Alta, Utah, at which time all interested persons in attendance shall be given the opportunity to be heard, for or against, the Budget; (c) orders that for at least ten days before the Hearing a copy of the Budget be available for public inspection (i) on the CWC website (www.cwc.utah.gov), (ii) at the CWC’s offices (311 South State Street, Ste. 330, Salt Lake City, Utah) during normal business hours, and/or (iii) on the Utah Public Notice website (<https://www.utah.gov/pmn/index.html>); and (d) orders that for at least seven days before the Hearing notice of the Hearing be (i) published on the CWC’s website, (ii) published on the Utah Public Notice website created in UTAH CODE ANN. 63A-16-601, and (iii) posted in a public place in each governmental entity (whether a town, city or county) that is a

regular member of the CWC that is likely to be seen by the residents of such member entity, all as required by UTAH CODE ANN. 63G-30-102(1).

This Resolution, assigned no. 2026-12, shall take effect immediately upon passage as provided herein.
