RESOLUTION 2026-02

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF TOOELE CITY, UTAH, TENTATIVELY ADOPTING A TENTATIVE BUDGET FOR FISCAL YEAR 2026-2027, AND ESTABLISHING THE TIME AND PLACE OF A PUBLIC HEARING TO CONSIDER ITS ADOPTION.

WHEREAS, the staff of the Redevelopment Agency of Tooele City, Utah ("RDA") has prepared and filed the tentative budget for Fiscal Year 2026-2027 with the RDA's Board of Directors; and,

WHEREAS, the tentative budget was prepared in accordance with the requirements of U.C.A. §17C-1-601, et seq., as amended; and,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE REDEVELOPMENT AGENCY OF TOOELE CITY, UTAH, that the fiscal year 2026-2027 tentative RDA budget is hereby adopted; and,

IT IS FURTHER RESOLVED that a public hearing to consider the final adoption of the Redevelopment Agency of Tooele City, Utah budget for 2026-2027 shall be held on the 17th day of June, 2026, at 7:00 p.m., at Tooele City Council Chambers located at 90 North Main Street, Tooele, Utah.

The City Recorder shall cause notice of a public hearing to consider its adoption to be published at least seven (7) days prior to the hearing by 1) posting notice of the public hearing at Tooele City Hall, and 2) publishing notice on the Utah Public Notice Website, and 3) on the home page of the Tooele City website, as required by U.C.A. §17C-1-601.5(4)(b).

The City Recorder shall cause the tentative budget approved hereby to be available for public inspection at least three days before the date of the public hearing, as required by U.C.A. §17C-1-601.5(4)(c).

3. **Resolution 2026-01 A Resolution of the Redevelopment Agency of Tooele City, Utah, Authorizing RDA Participation in Site Removal Costs for Building 595 Parcel #17-039-0-3801 Located at 1955 West B Avenue (Peterson Industrial Depot)**

Presented by John Perez, Economic Development Director

Mr. Perez presented a resolution authorizing reimbursement related to the removal of Building 595, located on West B Avenue within the Peterson Industrial Depot (PID), as shown in Exhibit A in council's packets. The request originated from PID, which initially sought \$600,000 toward the building's removal after the State estimated total demolition costs at approximately \$1 million. Through coordination with its partner company, Tekko, required certifications were obtained, reducing the total project cost to \$807,057.60.

Mr. Perez advised that following review and discussion in RDA Executive Committee meetings, the Agency reached an agreement to reimburse Tekko up to \$500,000 upon completion of the described demolition work. The removal of Building 595 is being undertaken to support a prospective manufacturing project identified through a State referral, with the intent of preparing the site for redevelopment and future job creation.

Exhibit B in council's packets outlined the scope of work and cost estimate provided by Tekko. Mr. Perez also confirmed that sufficient RDA fund balance is available to support the reimbursement, with the current Sunset RDA balance estimated at approximately \$6 million after accounting for existing commitments. The proposed expenditure aligns with the RDA's purpose of reinvesting in projects that support redevelopment and attract quality employment opportunities.

Motion: Board Member Brady moved to approve Resolution 2026-01 A Resolution of the Redevelopment Agency of Tooele City, Utah, Authorizing RDA Participation in Site Removal Costs for Building 595 Parcel #17-039-0-3801 Located at 1955 West B Avenue (Peterson Industrial Depot). Board Member Hansen seconded the motion. The vote was as follows: Board Member McCall, "Aye"; Board Member Hansen, "Aye"; Board Member Brady, "Aye"; Board Member Gossett, "Aye"; and Chairwoman Gochis, "Aye". The motion passed 5-0.
