**A RESOLUTION OF THE TOWN COUNCIL OF VIRGIN, UTAH, APPOINTING NEW MEMBER
OF THE PLANNING AND ZONING COMMISSION**

WHEREAS, Virgin Town (“Town”) is an incorporated municipality duly organized under the laws of the State of Utah, and

WHEREAS, Chapter 4 (Planning and Zoning Commission) Section 4.02(A) in the Virgin Uniform Land Use Ordinance (“VULU”) states, “For each new appointment, reaffirmation, or vacancy, it shall be done by written resolution, which shall state the member's name, the seat number being appointed, date of appointment, and date of seat expiration;” and

WHEREAS, Seat No. 3 of the Planning and Zoning Commission became vacant as of January 1, 2026, respectively;

WHEREAS, Seat No. 3 is a four-year term, and the newly appointed Planning and Zoning Commission member shall serve the remainder of the unexpired term, which expires January 1, 2028; and

WHEREAS, the Town of Virgin finds it necessary and appropriate to appoint an individual to fill Seat No. 3 on the Planning and Zoning Commission; and

THEREFORE, BE IT HEREBY RESOLVED by the Town Council of Virgin, Utah, that the following individual is hereby appointed to serve in the designated seat on the Virgin Town Planning and Zoning Commission.
