Primary Election Information

Ballots will be mailed out to all eligible voters beginning June 2, 2026. Voters must be of legal voting age, a citizen of the United States, and a resident of the voting precinct in which they are registered. If you have re-registered by the below deadlines, we will mail you a ballot to your new address. June 16-19:	Early voting; see early voting locations, dates and times below
June 16:	Last day to request an absentee ballot
June 23:	Ballot MUST be received by election officer by 8:00 p.m. on Election Day
June 23:	Election Day; see Election Day locations, date, and time below
June 23:	Unofficial Election results will be posted after 9:00 p.m.
July 1:	Election Audit at 10:00 a.m. in clerks office
July 7:	Canvass of the Primary Election at 10:00 a.m.
