A RESOLUTION OF THE BOARD OF TRUSTEES OF THE LOCAL BUILDING AUTHORITY OF THE CITY OF HOLLADAY ACCEPTING AND TENTATIVELY ADOPTING THE 2026-2027 LBA TENTATIVE BUDGET

WHEREAS, State law requires that the Local Building Authority of the City of Holladay (“LBA”) adopt a budget for the receipt and use of LBA funds; and
