- Director's Report

Nicole Jones presented the Director's Report to the board. Nicole presented on enrollment. Since January they have had a couple PCBL visits, observations and professional development. Teachers are focusing on targeted and explicit instruction. The school received a grant for professional development at the beginning of the year. Students are understanding the technology that is being used. Hosted a Leader in me professional development program. They did tours, learned from a speaker, watched announcements, watched student crews in action. Parent Teacher conferences took place in February. Attendance was 92% which is great. Enrollment is currently at 535

- Finance Report

Dawn Benke presented the Finance Report to the board. As of February 28th, the school year is 67% of the way through. Revenue is higher than expected due to

interest rates remaining higher than budgeted. PTIF is earning ample interest which is reflecting positively on the budget. There is nothing concerning in the budget at this time.
