Tabiona Town Mayor Terry Hughes welcomed everyone to the meeting and asked everyone to introduce themselves.

Consideration of Minutes from the January 26, 2026, Meeting

Commissioner Tracy Killian made a motion to approve the minutes from the January 26, 2026, meeting as presented. Duchesne City Mayor Deborah Herron seconded the motion. The motion passed with no opposing votes.

Discussion of County Road Project Impacts

(3:04 p.m.)

The County Commissioners gave an update on the County Roads they are working on this year. They are aligning State Street and Pole Line Road with the light on Highway 40. There is a hill on 6000 S that they would like removed to improve the line of sight. North Crescent should be paved by the end of this year. A parking lot on Highway 191 is being proposed for short-term truck parking by the cemetery. They are working with UDOT for this project. Duchesne City will need to approve the use of the land. Duchesne City Mayor Deborah Herron discussed a potential full-service truck stop between Myton & Duchesne.

The parties discussed the issues with overloaded trucks and the damage they cause. Roads in the Tabiona Valley are being graveled. A culvert was replaced on 3000 West, and others in Altonah will be replaced with the partnership with UDOT. They plan to roto-mill/double chip seal another 1.5 miles on Upper Red Creek (CR 1).

Discussion of Fire Restrictions

Commissioner Greg Miles stated that the County is at a critical point with fires. They are seeing fires already this year. The Revola Dugway Fire spotted out 1/3 mile away. This is not usual for March; it is normally seen in July. They are considering moving the burn window forward

instead of waiting until May 15th. The State is looking at restrictions. The Towns and Cities have to decide what restrictions they will enforce.
